

**MUNSTER SWIM CLUB
SPRING SPLASH INVITATIONAL MEET
MAY 7 & 8, 2010**

SANCTION: This meet is sanctioned by USA Swimming and Indiana Swimming Sanction #: #IN10287

HOST: *Munster Swim Club, P.O. Box 3119, Munster, Indiana 46321.*

LOCATION: *Munster High School, 8808 Columbia Avenue, Munster, Indiana 46321.*

FORMAT: *Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming*

Rules 202.3.2 At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warmup, competition, and warmdown. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

FACILITY: *6 lane, 25 yard pool with starting blocks. Colorado Timing with two (2) Back up timers per lane. Keifer nonturbulent lane markers. Adjacent locker rooms.*

The depth at the start end of the pool is: 4 feet

The depth at the turn end of the pool is: 14 feet

The competition course has not been certified in accordance with 104.2.2C(4).

ENTRY
DEADLINE: *All entry packets must be submitted via email (preferred method), U.S. Mail, or other delivery service. NO HAND DELIVERIES OR TELEPHONE ENTRIES WILL BE ACCEPTED. Entries will be accepted starting Friday, April 16, 2010. Entry Deadline is Friday April 23rd, 2010. **Entry deadline will be extended if meet is not full.** Email entries should be sent to: Matt Lee at matthewalee@comcast.net and will receive a return email confirmation upon receipt of the HyTek Team Manager file. Please note that this confirmation only acknowledges receipt of the file, not acceptance into the meet. The email entry must be followed up by a hard copy of the entry information, and submission of the hard copy prior to the entry deadline date would be appreciated. If not using email we recommend using FedEx, UPS, or other delivery service.*

ACCEPTANCE:
CRITERIA: *Entries will be accepted primarily in the order that they are received, but the number of officials provided by a club will also be considered. No teams will be broken, but entries will be limited to keep within the 4hour rule. We will notify teams being turned away by phone or email within 72 hours after the meet entry deadline, or 72hours after meet becomes full, whichever comes first.*

FEES: \$2.50 per Individual Event. \$5.00 per Relay. \$1.50 ISI Surcharge per athletes. Fees must accompany entry forms. Please make 1 check payable to MUNSTER SWIM CLUB. Entry fees for scratched events are nonrefundable. DECK ENTRIES WILL BE ACCEPTED.

ENTRY FORMAT:

THE FOLLOWING MUST BE SUBMITTED BY THE ENTRY DEADLINE:

- *HyTek Meet Manager file for entries. A printed copy of the team entry must also accompany the diskette. All times must be completed to the hundredth of the second. No times will be accepted;*
- *Team roster with each swimmers current USA Swimming number. Unattached swimmers must be entered independently of attached swimmers;*
- *Completed team summary report (included in this packet);*
- *Completed relay entry sheet (included in this packet);*
- *Executed release and hold harmless agreement (included in this packet)*
- *1 check for payment to all entry fees. Make check payable to “**Munster Swim Club**”*

SWIM SUIT

LEGISLATION: **10. EFFECTIVE (OCTOBER 1, 2009) USA Swimming Swim Suit Rule (102.9.1 B) wording shall be added to all meet letters**

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

IMPORTANT REMINDERS

- *Data on the disk must be consistent with the data on the print out(s).*
- *Unattached swimmers must be entered independently of attached swimmers.*

ENTRY LIMITATIONS:

Swimmers will be limited to 2 Individual events on Friday, 5 individual events on Saturday, and 1 relay.

ELIGIBILITY: *Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of May 7, 2010 will determine the swimmer's age for the entire meet. USA Swimming registration numbers must accompany the entry.*

CHECKIN/ SCRATCH:

This is a POSITIVE SIGN-IN MEET. Positive sign-in means, “I’m here. I intend to swim.” To sign-in positively, circle swimmer’s name on sign-in sheets. Sign-in sheets will be posted 30 minutes before the start of warm-ups for each session. The deadline for positive sign-in will be 20 minutes before the scheduled start of the session on Friday and 30 minutes before the scheduled start of each session (morning and afternoon) on Saturday. At that deadline, the sheets will be removed from the wall and no changes or corrections will be accepted. Any swimmer scratched under this rule may present to the Referee at least two minutes before the start of the slowest heat of the missed event and

request to swim in an empty lane. The Referee will honor such requests on a first come, first serve basis and only to the extent empty lanes are available.

CLERK OF COURSE: For the 11-12 and 13 & Over age groups, this invitational will be pre-seeded (i.e., cardless) and the lane and heat assignments will be posted at various points around the pool and hallways. The 9-10 and 8 & under age groups also will be pre-seeded, but a clerk of course will be operated for their events. However, positive sign-in is a requirement for all age groups. Absolutely no parents will be allowed on the pool deck. This is an insurance requirement of United States Swimming.

FINAL RESULTS: One complimentary copy will be provided to each club entering 5 or more swimmers. Additional copies may be ordered for \$8.00 each.

COACHES: Information packets will be distributed to the club coach upon arrival at the meet. A Coaches and Officials meeting will be held fifteen (15) minutes before the start of the each session. Coaches **MUST** constantly display their USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is no longer valid/current.

SCORING: We will be scoring the top 6 individual places and the top 6 relay places. Scoring will be as follows:
Individual Events: 16-13-10-7-4-1
Relays: 32-26-24-22-20-18

AWARDS: Individual Events: We will award ribbons through the first 6 places
Individual High Point Trophies for 1st, 2nd & 3rd place to girls and boys in each age group.
Relay: 1-6th medals

CONCESSIONS: Refreshments will be available at the concession stand on Friday and Saturday.

NOTE: Only Coaches and participating Officials are allowed on the pool deck. No food is allowed on the pool deck. **SMOKING IS NOT PERMITTED ANYWHERE IN MUNSTER HIGH SCHOOL.**
